It has been brought to our attention that the above matter was published in the Government Gazette on 28 December 2012 without informing CHASA and that the 21 days for presentations have already lapsed. An objection was lodged with the Head of the CFR and it was also requested that the date for presentations be extended in order to enable us to inform our members accordingly. Below for information is an apology received from the CFR and informing us that the date for presentations have been extended to 15 February 2013. NOTICE IN TERMS OF SECTION 136 (1) OF THE FIREARMS CONTROL ACT, 2000 (ACT NO. 60 OF 2000)

By virtue of the powers vested in me by section 136 (1) of the Firearms Control Act, 2000 (Act No. 60 of 2000), I, Mangwashi Victoria Phiyega, National Commissioner of the South African Police Service, in my capacity as Registrar of Firearms as contemplated in section 123 of the said Act, hereby give notice that the State intends to destroy all firearms, ammunition as well as firearm parts that were voluntarily surrendered to or forfeited to the State to date of publication of this notice.

In terms of section 136 (2) of the Firearms Control Act, 2000, any person who has a valid claim to such firearm or ammunition or such firearm parts may, within 21 days after the date of publication of this notice, make representations to me as to why such firearms or ammunition or such fire arm parts should not be destroyed. The representations must contain full information of the firearm, the owner of the firearm, and the police station where the firearm, the firearm parts and ammunition were voluntarily surrendered or forfeited. Any such representations must, within the stipulated period, reach me at the following address –
